- Liaising with the accounting department ensuring that charter hire invoices are approved and submitted timely.
- Work with the accounting department to ensure charterers expenses are correctly invoiced and controlled

- Review voyage instructions provided by Charterers and liaise with Charterers as required.
- Know, understand and ensure compliance with generic Charterer's Instructions, notifications and reporting requirements where applicable
- Cooperation with Charterers and vessels about all matters pertaining to Voyage Planning and Instructions for owned and chartered vessels
- Maintain adequate in-depth voyage records by all accepted documentation means including active voyage files, performance, emissions and emails.
- Quality assurance of noon reports and emissions reports
- Liaising with Insurances on voyage related matters to ensure timely notifications and arrangement of premiums
- Ensure new regulations are implemented and followed
- Ensure Ship / Shore compatibility studies are completed timely
- Various ad hoc operational and technical assignments to be expected.
